The Climate Restoration Safety & Governance Board Announces Official Launch And Roundtable Discussion About The Path Back to 300PPM

International review body to ensure that climate restoration projects are safe and effective

As world leaders, academics, business and NGO leaders, and environmental activists gather for COP27, the largest annual meeting on climate action, The Climate Restoration Safety & Governance Board (CRSGB) will officially launch. CRSGB is a global review body formed to ensure that climate restoration projects outside or across national boundaries are safe, legal, effective, transparent, and ethical. The Board will provide review, approval, certification and oversight for a growing number of projects capable of making a significant impact towards restoring global atmospheric CO₂ and methane to healthy pre-industrial levels. CRSGB will rely on input from top experts in climate restoration and associated fields, including scientists, engineers, ethicists and legal experts.

What: **The Path Back to 300PPM- Providing Transparency and Accountability and Achieving Ethical Consensus for Current and Emerging Climate Restoration Projects**- The official launch of the CRSGB: The Climate Restoration Safety & Governance Board, followed by a roundtable discussion with stakeholders - potential partners, funders, environmental organizations, youth and First Nation leadership focusing on fine-tuning CRSGBs application review, monitoring, and reporting procedures. In addition, Peter Fiekowsky will be signing copies of his groundbreaking book, *Climate Restoration*.
